You and Canada Fluorspar Inc

 - Canada Fluorspar Inc. will also invite International vendors to register as a vendor.

- Suppliers interested in pursuing opportunities with Canada Fluorspar Inc. are encouraged to take the following steps:
 - Learn about <u>our business</u> and understand <u>our expectations</u> of suppliers.
 - Complete our Supplier Registration form.



How to Become a CFI Vendor

- Self-registration application represents an expression of interest from the supplier to conduct business with CFI.
- Once submitted, your details will be assessed for inclusion on our prospective supplier database.
- Should your application be successful, your details will be maintained amongst a pool of prospective suppliers or be put through full trade qualification should CFI wish to conduct business with you.
- Should your services be specifically required you will be requested to complete a more comprehensive profile. Although you have submitted information, you may be required to complete additional manual forms.
- CFI reserves the right to verify all credentials submitted therein, prior to qualifying any supplier as an approved trade vendor / service provider.
- Once registered, you will receive an email notifying you of the outcome.



How to Become a CFI Vendor

- Registration, or indeed full trade qualification, does not guarantee any business from CFI, nor does it represent a contractual agreement or arrangement in any way.
- Potential Suppliers will be notified of specific opportunities via Request for Quotes (RFQ) or tender published on our tender boards on the CFI website.

- Vendor Registration Application
- Supplier Code of Ethical Conduct
