Senior Core Logging Geologist

Reporting to the Chief Geologist, this position will work a ten (10) day on / 4 day off work rotation. This is a hands-on, physical role and its primary focus is to support several planned exploration activities. We are looking for candidates who bring proven industry experience and are willing and able to work as part of a small work team. ***These positions are temporary in nature.***

DUTIES / RESPONSIBILITIES

- Responsible for conducting work in accordance with CFI's Safety and Environment Policies
- Responsible for daily drill contractor supervision and monitoring of all activities related to the project. This includes activity monitoring, consumables monitoring, quality control and sign-off of daily shift reports. Review and approval of contractor invoicing prior to submitting to Chief Geologist for final review and approval.
- Responsible for the correct and efficient execution of planned drilling programs as directed by the Chief Geologist
- Responsible for analytical data QA/QC and analytical laboratory invoicing review/approvals
- Responsible for supervision, training and quality work performance of Core Logging Geologist and Core Cutting/Sampling Technician
- Act as a technical resource for drilling contractors (i.e. set-up of diamond drill sites at specified azimuth and dip, assist in coordination of field activities)
- Perform regular inspections and addresses issues by identifying short-term and long-range effects associated with drilling activity
- Perform geological core logging duties in accordance with CFI's Core Logging Guidelines
- Input data for core logs, drilling shift reports, summary information and generate reports as directed by the supervisor and/or delegates
- Additional responsibilities to support the project as needed

- Possess a post secondary education in geology and be registered as a P. Geo or GIT with PEGNL
- Minimum of five (5) years experience in mineral exploration, including previous core logging experience
